

Price Summary for Federal Subscribers Accessing Westlaw® through FEDLINK

Concurrent User Pricing Option – Direct Express



This is a summary of Federal Government Concurrent User Pricing Option prices effective October 1, 2011 through September 30, 2012. Purchase of these services is governed by an Indefinite Delivery Indefinite Quantity Contract ("Contract") with the Library of Congress (FEDLINK). Please see the Contract for complete details.

Under the Concurrent User Option, an Agency (or any division of an Agency or any combination of divisions of an Agency), will pay a monthly guarantee for access to and use of Westlaw Databases only ("Westlaw Monthly Guarantee"), Westlaw and NewsRoom Databases ("Westlaw and NewsRoom Monthly Guarantee") and/or Westlaw Public Records Databases and Services ("Westlaw Public Records Monthly Guarantee") for the number of authorized concurrent users ("Concurrent Users"), regardless of the number of passwords issued to the Agency. The Westlaw Public Records Monthly Guarantee must be combined with a current Westlaw subscription, including but not limited to, the Per Minute/Transactional Option, Fixed Monthly Charge Option or the Westlaw Monthly Guarantee or the Westlaw - NewsRoom Monthly Guarantee under the Concurrent User Option.

Two options will be available when users, in excess of the number of authorized Concurrent Users, attempt to access the Westlaw, Westlaw and NewsRoom or Westlaw Public Records options.

Under **Option 1**, a user in excess of the number of authorized Concurrent Users will receive a "warning screen" and **will not** be permitted to access the service at that time and will need to re-enter his/her password at a later time.

Under **Option 2**, a user in excess of the authorized number of Concurrent Users, will receive a "warning screen" and will receive access to the applicable service. All charges associated with usage by such user(s) for that particular sign-on will be billed to the Agency at then-current Per Minute/Transactional Option rates are in addition to the Westlaw Monthly Guarantee, the Westlaw and NewsRoom Monthly Guarantee or the Westlaw Public Records Monthly Guarantee.

West will assist the agency in determining the number of Concurrent Users necessary to meet the Agency's computer-assisted research needs Agency based upon the Agency's applicable past online use, the historic traffic patterns and forecasted use based on employment projections and work loads. The Agency must notify West in writing of its acceptance of the Concurrent User Option at least five (5) working days prior to the first day of the month in which the Concurrent User Option is to be effective.

The Westlaw Monthly Guarantee will include access to and use of the following:

All Westlaw databases, features and services (except Excluded Charges as set forth below):

The Westlaw and NewsRoom Monthly Guarantee will include access to and use of all databases, features and services included in the Westlaw Databases Monthly Guarantee and all NewsRoom Databases.

West reserves the right to bill as Excluded Charges any new databases, features or services released on Westlaw, NewsRoom and Westlaw Public Records.

West or the Agency may terminate the Concurrent User Option upon thirty (30) days prior written notice. The Agency may then elect the Per Minute/Transactional Option rates or the Fixed Monthly Charge Option. If the Agency elects the Fixed Monthly Charge, the Agency will receive unlimited simultaneous access at the current Westlaw Monthly Guarantee or Westlaw and NewsRoom Monthly Guarantee, as applicable, for three consecutive months. The Agency's actual usage and Westlaw charges (billed at Per Minute/Transactional Option rates) during that time will be used to determine the Fixed Monthly Charge.

The Concurrent User Options will be billed as set forth below:

If an Agency desires to increase the number of concurrent users, the rate for the additional concurrent user(s) will be set at the mid-point between the current Monthly Guarantee the Agency is paying under the Concurrent User Option and the rate set forth above for the new number of concurrent users desired by the Agency. The Agency must notify West of any increase in the number of concurrent users at least five (5) working days prior to the first day of the month in which the additional concurrent user(s) is (are) to be effective. If an Agency retains the same number of Concurrent Users in subsequent fiscal years, a 5% increase will be applied to the applicable Monthly Guarantee.

West or the Agency may terminate the Concurrent User Option upon thirty 30 days prior written notice to the other party. The Agency may then elect the Per Minute/Transactional Option rates, the Fixed Monthly Charge Option or the Volume Discount Option.
