# Forum and Document Page Searching

---


- Searching within Forums and Document pages allows users to search for items from within forums or document pages.
- Searches can be conducted within specific forums or document pages, or within all forum and document pages.
- Users may search postings by keywords, dates and/or by author (including anonymous authors).
- Search results are displayed in a sortable table format. Clicking on the item displayed in the search results takes the user to the item and marks it read for both participation and display purposes.

# Sign-Up Sheet Redesign

---

- Redesigned to allow users to create and view sign-up sheets in a more visually pleasing way.
- Along with the visual changes, functionality has been added to allow the administrator to enter descriptive text into an HTML editor and to share sign-up sheets between courses.
- Administrators may allow multiple participants to sign up for a single slot and may allow participants to enter optional text when they sign up.
- Administrators also have the option to be sent an e-mail when students remove their name from the sheet.



# Law School Exchange and TWEN Integration

---

- Faculty will have the ability to quickly add their content residing within Law School Exchange into TWEN.
  - Law Professors can easily add content from their LSE “My Materials” and “My Favorites” locations.
  - Content chosen by professors for student viewing via TWEN can be presented in greater variety of formats (e.g. PDF, Word, WordPerfect, Multimedia (Audio & Video)).
- The Law School Exchange and TWEN integration will present the Law Students with a more powerful document viewing tool.
  - Students can highlight, comment, and annotate documentation provided in the LSE (TWEN) Viewer. Annotations are specific to that student’s view of the document.
  - Law Students will have access to content purchased via TWEN for 12 months beginning from the date of purchase.



# TWEN and Law School Exchange – Faculty View

## Adding Material:

1. Within TWEN, choose the course you wish to add material via the “Add form LS Exchange”.
2. Seamless access to LSE “My Materials” and “My Favorites” tabs.
3. Clear account of number of items and any associated cost to Law Students.


